Any individual involved in Ornamental Horticulture and not eligible for Interim or Associate membership. (I.e.: Not involved in any commercial activity.) Individuals employed by non-member companies are not eligible for this category of membership. Some restrictions apply to this category.

☐ Affiliate

Associations, city, town, county, and municipal or improvement district. Institutions providing ornamental horticultural services e.g. hospitals, colleges, university, research facility, zoo or theme park etc. Private or public golf courses.

Out of Province, Individual, and Affiliate members are not eligible for CNLA membership.
