Our organization does not usually collect personal information from individuals, other than business contact information, which is not considered to be personal information under Bill 44 - *Personal Information Protection Act* (PIPA) in Alberta, and may be collected, used and disclosed without consent. Our privacy policy complies with the requirements of the Personal Information Protection and Electronic Documents Act of Canada (PIPEDA). In the event that we do collect personal information, that information will only be used by us to administer member services and activities directly relating to the Association. We disclose member information to the following third party: Canadian Nursery Landscape Association (CNLA). We disclose this information in order to provide member benefits. On occasion, we disclose member information to affinity group parties for the administration of group purchase/affinity programs available to our members only. Partnership, Corporation or Proprietorship actively engaged in one or more of these business categories:

Tree Nursery Producer, Landscape Construction and/or Maintenance Contractor, Lawn Care Provider, Arborist, Greenhouse Operator, Garden Centre Operator, Sod Producer, Irrigation Contractor, Landscape Designer, Horticultural Consultant.

Active category applicants require the recommendation of two member "sponsors" (see details at bottom of page). Sponsorship establishes that applicant companies have operated successfully in the industry for a period of time and have positive business relationships with suppliers and industry peers.

Associate

Businesses supplying material, products and/or services to the Landscape/Horticultural industry (that fall outside the businesses eligible for Active category membership as described above).

Affiliate

- Sales up to \$750,000..... \$ 922.28 +GST**
- Sales \$750,000 to \$1,500,000..... \$ 1,223.38 +GST**
- Sales \$1,500,000 to \$3,000,000..... \$ 1,709.74 +GST**
- Sales over \$3,000,000..... \$ 2,664.55 +GST**
